SCHEME OF RECRUITMENT FOR THE POST OF SENIOR PROFESSOR

Your attention is invited to the paragraph 6 of the Commission Circular No. 05/2015 dated 28.05.2015 on the Scheme of Recruitment for the post of Senior Professor.

- 2. As per the provisions of paragraph 6 of Commission Circular No. 05/2015, only the existing staff members and those who become eligible within a period of two years were allowed to apply for the post of Senior Professor under the provisions of Commission Circular No. 838 dated 26.01.2004 as amended by Commission Circular No. 897 dated 08.07.2008, but no restriction has been imposed for them with respect to the period of submitting applications for the Senior Professorship.
- 3. Further, two years period has already been passed from the completion of granted two years period: up to $31^{\rm st}$ May 2017, to become eligible to apply for the post of Senior Professor under the provisions of Commission Circular No. 838 as amended by Commission Circular No. 897.
- 4. Therefore, the Commission at its 1007th and 1022nd meetings decided that the academic staff members are not entitled to make applications for the post of Senior Professor under the provisions of Commission Circular No. 838 as amended by Commission Circular No. 897, with effect from 02.12.2019.
- 5. The provisions of the Commission Circular No. 05/2015 are remain unchanged subject to the amendment made for the paragraph 6 of the same, as mentioned in 4 above.

6. Please take action accordingly and also bring this to the notice of all Academic Staff.
