C4,C5,C6,C7,C8,C9,SP1 & EM1 in the above list should have a valid registration in the Construction Industry Development Authority (CIDA ) or (Earlier Institute for Construction Training and Development /ICTAD) (Please attach a copy of CIDA/ICTAD certificate for the relevant field) This condition is not applicable to Government Sector organizations".

Applications should be prepared according to the specimen appended below and sent under registered cover with "Registration of Suppliers Year 2024" marked on the top left-hand corner of the envelop to reach Assistant Bursar, Supplies Division, Rajarata University of Sri Lanka, Mihintale on or before 07<sup>th</sup> January 2024.

Non – refundable fees of **Rs. 1,000.00** per sub item should be paid to the university and receipt enclosed with the application. All payments should be made by deposit to the Rajarata University of Sri Lanka Account No 008-1-001-8-1725841 of Peoples Bank, Anuradhapura or use the payment gateway available in <a href="https://payment.rjt.ac.lk//individual/">https://payment.rjt.ac.lk//individual/</a> Applicants who do not satisfy the following conditions will not be considered for registration.

- 1. Suppliers/ Contractors/ Service Providers who are already registered with the University should reapply for new registration for year 2024.
- 2. Applicant should have at least three years' experience of supplying the relevant items (Goods/Works/ Services).
- 3. Relevant organization should possess a valid business registration & copy of the certificate of registration should be attached.

- 4. If the intended supplier is a limited liability company, certificate of incorporation of the company should be annexed with the application.
- 5. If the intended supplier is an organization other than non-limited liability company, a copy of the certificate of registration should be attached.
- 6. The Registration certificate of CIDA/ICTAD in connection with the construction contractors should be attached.
- 7. Every supplier should agree to provide a credit facility at least for 30 days.

8.	VAT Registration certificate or the VAT exemption certificate issued by the Commissioner General of Inland Revenue should be attached.
